## RUSSIA: 159 "anti-missionary" prosecutions in 2018 - list

*Forum 18 has found 159 prosecutions in all of 2018 (56 of organisations and 103 of individuals) for violating Russia's July 2016 Administrative Code Article 5.26 "anti-missionary" restrictions. 132 of the 2018 prosecutions resulted in initial convictions (129 fines). 2018 saw a conviction rate of 90 per cent, compared with an 82 per cent conviction rate in the year from July 2016. Three foreigners were ordered deported, and one of the deportations was overturned on appeal).*

There were in all of 2018 at least 159 prosecutions of individuals and communities for violating Russia's "anti-missionary" restrictions under Administrative Code Article 5.26, Part 3 ("Implementation of activities by a religious organisation without indicating its official full name, including the issuing or distribution, within the framework of missionary activity, of literature and printed, audio, and video material without a label bearing this name, or with an incomplete or deliberately false label"), Part 4 ("Russians conducting missionary activity"), and Part 5 ("Foreigners conducting missionary activity").

This marks a decrease in the overall number of such prosecutions compared with the first year of the legislation's implementation from July 2016. This appears to be primarily explained by the sharp drop in the number of Administrative Code Article 5.26 cases against Jehovah's Witnesses, whose activities were outlawed as "extremist" by Russia's Supreme Court in 2017 ([http://www.forum18.org/archive.php?article\\_id=2474](http://www.forum18.org/archive.php?article_id=2474)). As a result of the ban there has been a steep rise in Jehovah's Witnesses held in pre-trial detention, under house arrest, and under travel restrictions as over 100 face "extremism"-related criminal charges ([http://www.forum18.org/archive.php?article\\_id=2453](http://www.forum18.org/archive.php?article_id=2453)).

Forum 18 found in 2018 159 Administrative Code Article 5.26 prosecutions which reached court of 56 organisations and 103 individuals. Of these, 132 resulted in conviction, with 129 fines being imposed. 2018 saw a conviction rate of 90 per cent, compared with 82 per cent in 2016-17.

Of the 14 foreigners charged, three were ordered deported (in the form of monitored independent departure), although one had this overturned on appeal.

More than half of Russia's federal subjects have seen at least one prosecution. Russian citizens comprise the overwhelming majority of individual defendants.

A number of the prosecutions listed below followed surveillance by the FSB security service of people exercising freedom of religion and belief. The FSB then informed prosecutors office officials or the ordinary police, who then initiated prosecutions the people or community involved.

These prosecutions are based on changes to the Administrative Code and Religion Law introduced in July 2016 as part of the "Yarovaya" package of "anti-terrorism" laws ([http://www.forum18.org/archive.php?article\\_id=2246](http://www.forum18.org/archive.php?article_id=2246)).

Russia has also imposed its "anti-missionary" legislation in Crimea, which it annexed in 2014. ([http://www.forum18.org/archive.php?article\\_id=2441](http://www.forum18.org/archive.php?article_id=2441))

All prosecutions under Administrative Code Article 5.26, Parts 3, 4, and 5 known to have reached court in the calendar year 2018 are listed below, ordered by date of court hearing. The list is based on court decisions and court records seen by Forum 18 and other information.

Administrative Code Article 5.26, Part 3

- Known Administrative Code Article 5.26, Part 3 cases ("Implementation of activities by a religious organisation without indicating

its official full name, including the issuing or distribution, within the framework of missionary activity, of literature and printed, audio, and video material without a label bearing this name, or with an incomplete or deliberately false label")

A fine of 50,000 Roubles (about 6,700 Norwegian Kroner, 690 Euros or 770 US Dollars) represents nearly six weeks' average wages for those in work or 16 weeks' average state retirement pension.

1) 12 January 2018

Name: Sarov Society for Krishna Consciousness

Punishment: 30,000 Roubles

Court: Sarov District Magistrate's Court No. 2, Nizhny Novgorod Region

Circumstances: Hare Krishna community charged with not displaying its full official name at its registered address – defence argued that this is only its legal address and no religious worship takes place there, only a yearly meeting of the board, and that the full official name is posted on the inner door of the flat (not on the outer, as they are afraid of the reaction of other people); judge notes that the law does not specify what sort of "activity" needs to take place for display of the full official name to be required, therefore should be shown wherever any meeting is held

Appeal: none

2) 16 January 2018

Name: Russian Evangelical Christian Church (centralised religious organisation)

Punishment: 30,000 Roubles

Court: Yuzhnoye Tushino District Magistrate's Court No. 164, Moscow

Circumstances: after Justice Ministry inspection of compliance with the Religion Law, organisation charged with not using its full official name on its website

Appeal: unsuccessful – 28 May 2018, Tushino District Court, Moscow

3) 18 January 2018

Name: Restoration Evangelical Christian Church

Punishment: 30,000 Roubles

Court: Central District Magistrate's Court No. 2, Kaliningrad

Circumstances: church charged with not displaying a sign with its full official name at its rented premises

Appeal: none

4) 18 January 2018

Name: Liberation in Jesus Pentecostal Church

Punishment: 30,000 Roubles

Court: Kungur Magistrate's Court No. 3, Perm Region

Circumstances: church charged with having "carried out its activities...without displaying its full official name" – ie. the sign on its building omits the phrase "local religious organisation" and the word "Pentecostals"; found during prosecutor's office inspection of compliance with anti-extremism legislation; lawyer argued that the community had no funds to pay a fine

Appeal: unsuccessful – 27 February 2018, Kungur City Court, Perm Region; supervisory appeal unsuccessful – 24 April 2018, Perm Regional Court

5) 7 February 2018

Name: Transfiguration Baptist Union Church

Punishment: warning

Court: Khasansky District Magistrate's Court No. 91, Primorye

Circumstances: church charged with not using its full official name on documents it submitted to the regional Justice Ministry branch for an inspection

Appeal: none

6) 16 February 2018

Name: Full Blessing Evangelical Church

Punishment: 30,000 Roubles

Court: Moscow District Magistrate's Court No. 4, Kaliningrad

Circumstances: church charged with having "carried out its activity .. without displaying its full official name" on its door

Appeal: none

7) 22 February 2018

Name: Shakhunya Seventh-day Adventist Church

Punishment: 30,000 Roubles

Court: Shakhunya District Magistrate's Court No. 1, Nizhny Novgorod Region

Circumstances: church charged with holding meetings for worship in a house which had a sign reading "Seventh-day Adventist Church" hanging to the left of the door; found by police, who interrupted a meeting for worship after receiving a message about "suspicious people" gathering; there was a sign with the church's full official name on the inside of the building – lawyer Vasili Nichik claims the signs had been swapped by an official; witnesses claim that until recently, the sign had shown the full official name; "[In law] All doubts are interpreted in favour of the [defendant]. The community does not have a bank account or any property to pay the fine. Almost all believers are pensioners. The nature and extent of the damage is incommensurable. Officials could simply point out that there is a problem. In fact, there was no reason to talk about the presence of an administrative offence. The law requires that there be a sign with the full name of the organisation, but there is no norm in the Law [which requires] the sign to be outside"

8) 28 February 2018

Name: To the Ends of the Earth Evangelical Church

Punishment: 30,000 Roubles

Court: Kirov District Magistrate's Court No. 4, Ufa, Republic of Bashkortostan

Circumstances: church charged with "carrying out its activities" without displaying its full official name at the entrance to the building or on the walls, as found by prosecutor's office inspection of compliance with the Religion Law; defence argued that an appropriate sign was displayed inside the building's hallway and on the door of the room rented for worship, by agreement with the building's owner

Appeal: unsuccessful – 17 April 2018, Kirov District Court, Ufa; supervisory appeal unsuccessful – 4 July 2018, Supreme Court of Bashkortostan

9) 12 March 2018

Name: Good News Mission of Evangelisation and Charity of Evangelical Christians (Pentecostals)

Punishment: 30,000 Roubles

Court: Kirov District Magistrate's Court No. 4, Ufa, Republic of Bashkortostan

Circumstances: church "carried out a meeting for worship with the participants of members of this religious organisation without displaying its official full name at the entrance to the building or on the walls of the building by the entrance, in the form of a sign or plaque" – found by prosecutor's office inspection

Appeal: none

10) 12 March 2018

Name: Reconciliation Baptist Union Church

Punishment: none – acquitted

Court: Yoshkar-Ola Magistrate's Court No. 9, Mari El Republic

Circumstances: church charged with distributing religious literature to the public which did not bear its full official name; found during planned Justice Ministry inspection of documents; also charged under Part 4; judge decides that there is no proof that the unmarked literature presented in court is the same as that distributed during the alleged missionary activity, which "does not allow for an objective conclusion to be drawn about the presence or absence of markings on the products distributed by the missionaries"

Appeal: by Justice Ministry; case sent back for re-examination – 9 April 2018, Yoshkar-Ola City Court; acquittal upheld on re-examination – 26 April 2018, Yoshkar-Ola Magistrate's Court No. 9

11) 13 March 2018

Name: House of the Gospel

Punishment: 30,000 Roubles

Court: Naberezhniye Chelny Magistrate's Court No. 7, Republic of Tatarstan

Circumstances: Evangelical church charged because it "carried out its activities" (i.e. held a meeting for worship) "without displaying its full name", as established during a police inspection of its rented premises; pastor argued that there was a sign inside the building, and that the church's full name was also displayed on leaflets explaining the meeting for worship and on a screen in the hall

Appeal: unsuccessful – 6 June 2018, Naberezhniye Chelny City Court, Republic of Tatarstan

12) 14 March 2018

Name: Pomorian Old Orthodox Church (centralised religious organisation)

Punishment: 30,000 Roubles

Court: Preobrazhenskoye District Magistrate's Court No. 111/113, Moscow

Circumstances: priestless Old Believer church; did not display full official name – details not given in verdict

Appeal: none

13) 15 March 2018

Name: Ark Evangelical Church

Punishment: none – because of "insignificance" of "offence"

Court: Sevsk District Magistrate's Court No. 51, Bryansk Region

Circumstances: church charged with having a sign on its building which did not exactly match its full official name; police officer in

court (not the one who carried out the police inspection) states that this had no "harmful or dangerous consequences"; judge decides to free church from administrative responsibility

Appeal: none

14) 16 March 2018

Name: House of the Living God Evangelical Church

Punishment: 30,000 Roubles

Court: Rezh District Magistrate's Court No. 1, Sverdlovsk Region

Circumstances: church charged with not having a sign with its full official name on the outside of the building where it holds meetings for worship – pastor argues that registration paperwork with the full official name is posted on the door of the room where meetings for worship take place, and that he did not point this out during the prosecutor's office inspection, because he did not know what the inspection was for

Appeal: unsuccessful – 25 April 2018, Rezh District Court, Sverdlovsk Region; supervisory appeal unsuccessful – 24 August 2018, Sverdlovsk Regional Court

15) 19 March 2018

Name: Jesus Embassy Pentecostal Church, Kstovo

Punishment: 30,000 Roubles

Court: Kstovo Magistrate's Court No. 2, Nizhny Novgorod Region

Circumstances: church charged with "carrying out its activities" without displaying a sign with its full official name, as established during police inspection; defence insisted that two signs were in place, one to the right of the front door of the flat where meetings for worship are held, one on the wall immediately inside the flat

Appeal: supervisory appeal rejected without consideration – 15 June 2018, Nizhny Novgorod Regional Court

16) 20 March 2018

Name: V.I. Matveychuk

Punishment: none – sent back by judge

Court: Nyagan Magistrate's Court No. 2, Khanty-Mansi Autonomous Region

Circumstances: same case as Evangelical Church of Jesus Christ (below)

Appeal: none

17) 1 April 2018

Name: Mary, Queen of Peace Roman Catholic Church

Punishment: 30,000 Roubles

Court: Berezniki Magistrate's Court No. 49, Perm Region

Circumstances: church charged with uploading videos of church activities to the internet, which did not show its full official name; apparently found by FSB security service monitoring; defence argued that these were uploaded on a non-official basis by congregation members

Appeal: unsuccessful – 28 May 2018, Berezniki City Court, Perm Region

18) 6 April 2018

Name: Life Evangelical Church

Punishment: 30,000 Roubles

Court: Chernovsky District Magistrate's Court No. 11, Chita

Circumstances: church charged with posting material (photos, videos, information about meetings for worship) in a publicly accessible group on VKontakte without including its full official name, as well as links to its website and YouTube channel, which also do not display its full official name – found by FSB security service

Appeal: unsuccessful – 21 December 2018, Chernovsky District Court, Chita; supervisory appeal unsuccessful – 6 March 2019, Zabaykalsk Regional Court

19) 15 April 2018

Name: Mari Evangelical Church

Punishment: none – because of insignificance of offence

Court: Yoshkar-Ola Magistrate's Court No. 7, Mari El Republic

Circumstances: church charged with failing to display a sign on its building with its full official name – found by prosecutor's office inspection; sign by the door showed an incomplete name (apparently lacking only the name of the town); defence pointed out that the building is a private house on land designated for residential use, which is continuously lived in, and the church uses only one room – also argued that the law requires the display of a religious organisation's full official name, but does not specify what form this should take; judge decides that the church should be freed from administrative responsibility because the offence "did not lead to significant socially dangerous consequences, and therefore does not represent a significant violation of protected social relations".

Appeal: none

Name: Kurgan Regional Union of Baptist Churches

Punishment: 30,000 Roubles

Court: Petukhovo District Magistrate's Court No. 19, Kurgan Region

Circumstances: regional religious organisation fined because the Light of Truth Baptist church (a religious group) did not include the organisation's name on its sign, as established during inspection by prosecutor's office

Appeal: unsuccessful – 14 June 2018, Petukhovo District Court, Kurgan Region

21) 18 April 2018

Name: Vladimir Ananyev

Punishment: 15,000 Roubles

Court: Kalinin District Magistrate's Court No. 10, Ufa, Republic of Bashkortostan

Circumstances: pastor of House of God Evangelical Church (religious group) charged for giving a man a book – "Alone with God", by Richard Wurmbrand – "as part of missionary activity", which was not labelled with a religious organisation's full official name; district prosecutor's office and police Centre for Combating Extremism carried out inspection on the information of Republic prosecutor's office and apparent tip-off from an individual; defendant argued that acquaintances came of their own accord to pray at his home and that the man himself asked to read the book; fine reduced because defendant has two underage children; also charged under Part 4

Appeal: none

22) 24 April 2018

Name: Nagayevskoye Muslim community

Punishment: 30,000 Roubles

Court: Karsun District Magistrate's Court No. 1, Ulyanovsk Region

Circumstances: Muslim community charged for failing to display a sign on its mosque with its full official name – found by prosecutor's office inspection

Appeal: none

23) 28 April 2018

Name: Jesus Embassy Church (centralised religious organisation)

Punishment: 30,000 Roubles

Court: Moscow District Magistrate's Court No. 6, Nizhny Novgorod

Circumstances: Pentecostal church charged for posting video (in 2016) on VKontakte showing international students talking about their experiences as church members, which did not display the church's full official name; also charged under Part 4

Appeal: unsuccessful – 8 June 2018, Moscow District Court, Nizhny Novgorod

24) 10 May 2018

Name: Khimki Muslim community

Punishment: 30,000 Roubles

Court: Khimki Magistrate's Court No. 258, Moscow Region

Circumstances: religious organisation charged for displaying religious literature and information on Islam on a table in the corridor outside their prayer room – material was not marked with the organisation's full official name; also charged under Part 4

Appeal: none

25) 15 May 2018

Name: Makhalla No. 486

Punishment: 30,000 Roubles

Court: Soviet District Magistrate's Court No. 6, Astrakhan

Circumstances: Muslim community charged for failing to display a sign on its building with its full official name – found during prosecutor's office inspection

Appeal: none

26) 15 May 2018

Name: King Jesus Evangelical Church

Punishment: 30,000 Roubles

Court: Dzerzhinsky District Magistrate's Court No. 5, Perm

Circumstances: church charged for posting videos of church events on YouTube which did not show its full official name – found by FSB security service

Appeal: unsuccessful – 9 July 2018, Dzerzhinsky District Court, Perm; supervisory appeal unsuccessful – 3 September 2018, Perm Regional Court

27) 29 May 2018

Name: Russian United Methodist Church

Punishment: 30,000 Roubles

Court: Khamovniki District Magistrate's Court No. 365, Moscow

Circumstances: centralised religious organisation charged after planned Justice Ministry inspection of documentation, for not displaying its full official name on copies of a hymn book (the phrase "Centralised Religious Organisation" was omitted)

Appeal: unsuccessful – 30 October 2018, Khamovniki District Court, Moscow

28) 31 May 2018

Name: Vifaniya Baptist Union Church

Punishment: 30,000 Roubles

Court: Avtozavodsky District Magistrate's Court No. 3, Nizhny Novgorod

Circumstances: church charged for "carrying out religious activity without displaying its full official name", ie. failing to have a sign on its building; the pastor (who owns the house where meetings for worship are held) argued that there is a sign on the door of the room used for meetings for worship, and the law does not specify where an organisation's name should be displayed; police officer agreed that there was a sign on an internal door, but pointed out that outer clothing belonging to visitors was hanging in a corridor before this room

Appeal: none

29) 5 June 2018

Name: Evangelical Church of Jesus Christ

Punishment: none – acquitted

Court: Nyagan District Magistrate's Court No. 3, Khanty-Mansi Autonomous District

Circumstances: church charged for not displaying its full official name at the entrance to the hall it was using for worship in a house of culture; police inspected premises after receiving information about an "unsanctioned gathering"; judge agrees with defence that two information panels with the correct details had indeed been set up, one outside and one inside the hall

Appeal: none

30) 13 June 2018

Name: Exaltation of the Holy Cross Roman Catholic Church

Punishment: 30,000 Roubles

Court: Lenin District Magistrate's Court No. 5, Ufa, Republic of Bashkortostan

Circumstances: church charged for distributing literature not labelled with its full official name – details unspecified

Appeal: none

31) 17 June 2018

Name: Exaltation of the Holy Cross Roman Catholic Church

Punishment: 30,000 Roubles

Court: October District Magistrate's Court No. 12, Ufa, Republic of Bashkortostan



Circumstances: church charged for distributing magazines not labelled with its full official name – details unspecified

Appeal: none

32) 19 June 2018

Name: Russian Central United Christian-Presbyterian Society

Punishment: 30,000 Roubles

Court: Yasenevo District Magistrate's Court No. 60, Moscow

Circumstances: organisation charged for using an incomplete name in its official stamp on the report of its 2017 activities submitted to the Justice Ministry

Appeal: none

33) 3 July 2018

Name: Orthodox Jewish Community of Yoshkar-Ola

Punishment: 30,000 Roubles

Court: Yoshkar-Ola Magistrate's Court No. 3, Mari El Republic

Circumstances: community charged for "carrying out its activities without using its full official name", ie. in paperwork submitted to the Justice Ministry for a planned document check, it had used the abbreviated form "MROOI 'Yevreyskaya Obshchina g. Yoshkar-Ola'", or simply "Yevreyskaya Obshchina g. Yoshkar-Ola", instead of the full form: "Mestnaya Religioznaya Organizatsiya Ortodoksalnogo Iudaizma 'Yevreyskaya Obshchina g. Yoshkar-Ola'"

Appeal: none

34) 17 July 2018

Name: Naberezhniye Chelny Seventh-day Adventist Church

Punishment: none – case sent back

Court: Naberezhniye Chelny Magistrate's Court No. 12, Republic of Tatarstan

Circumstances: unknown – did not display full official name

Appeal: none

35) 17 July 2018

Name: Word of Life Evangelical Church

Punishment: 30,000 Roubles

Court: Central District Magistrate's Court No. 4, Orenburg

Circumstances: church charged for not having a sign with its full official name on the facade of its building, as established during prosecutor's office inspection; defence argued that a temporary sign was placed outside during meetings for worship, and that there is no direct obligation in law for such a sign to be permanent

Appeal: unsuccessful – 28 August 2018, Central District Court, Orenburg

36) 27 July 2018

Name: Community of Evangelical Christian-Baptists, Chelyabinsk

Punishment: 30,000 Roubles

Court: Lenin District Magistrate's Court No. 7, Chelyabinsk

Circumstances: Baptist Union church charged for not having a sign on its facade showing its full official name; defence argued that the sign had fallen into disrepair and had been replaced the day after the prosecutor's office inspection of compliance with the Religion Law (which was carried out according to information from the police Centre for Combating Extremism)

Appeal: none

37) 12 August 2018

Name: Glorification Pentecostal Church, Abakan

Punishment: 30,000 Roubles

Court: Abakan Magistrate's Court No. 12, Republic of Khakasiya

Circumstances: church charged for not using its full official name on its Facebook page and YouTube channel

Appeal: unsuccessful – 10 October 2018, Abakan City Court, Republic of Khakasiya

38) 17 August 2018

Name: Tabernacle of Faith Pentecostal Church

Punishment: 30,000 Roubles

Court: Syzran Magistrate's Court No. 82, Samara Region

Circumstances: as part of an unscheduled inspection of compliance with the Religion Law, the Justice Ministry requested copies of the church's documents and any literature it was distributing – church accused of "using a shortened name in its activities"

Appeal: unsuccessful – 18 September 2018, Syzran City Court, Samara Region

39) 22 August 2018

Name: Arkhangelsk Bible Church

Punishment: 30,000 Roubles

Court: October District Magistrate's Court No. 4, Arkhangelsk

Circumstances: Baptist Union church failed to display full official name – details unknown

Appeal: twice rejected because submitted too late – 26 September and 19 November 2018, October District Court, Arkhangelsk

40) 28 August 2018

Name: Nyagan Seventh-day Adventist Church

Punishment: none – because of insignificance of offence

Court: Nyagan District Magistrate's Court No. 1, Khanty-Mansi Autonomous District

Circumstances: church charged for not displaying its full official name on the facade of its building, after prosecutor's office inspection of its compliance with the Religion Law; judge concluded that the violation "did not carry a significant threat to protected public relations" and accepted that it had been "promptly eliminated" by the church

Appeal: none

41) 29 August 2018

Name: Moscow Baptist Theological Seminary

Punishment: 30,000 Roubles

Court: Perovo District Magistrate's Court No. 290/291, Moscow

Circumstances: after Justice Ministry inspection of compliance with the Religion Law, seminary charged for not using its full official name on its website and in April 2018 issues of its electronic journals "Vestnik" and "Informatsionniy Vestnik"

Appeal: none

42) 11 September 2018

Name: Hope Mission of Evangelical Christians of Chelyabinsk

Punishment: unknown fine

Court: Metallurgical District Magistrate's Court No. 1, Chelyabinsk

Circumstances: church charged for failing to display its full official name on the facade of its building – found by prosecutor's office "inspection of compliance with the [Religion Law]"

Appeal: none

43) 20 September 2018

Name: Kadriya Makhalla

Punishment: 30,000 Roubles

Court: Meleuz Magistrate's Court No. 2, Republic of Bashkortostan

Circumstances: Muslim community charged for having religious literature "freely available for visitors to the mosque", as found during prosecutor's office inspection of compliance with the Religion Law, and for showing only the shortened name "Kadriya Mosque" on its facade; judge notes definitions of "marking" and "distribution" from Constitutional Court statement of 7 December 2017

Appeal: none

Name: Oleg Gugin

Punishment: 30,000 Roubles

Court: Lipetsk District Magistrate's Court No. 2, Lipetsk Region

Circumstances: chairman of Church of Evangelical Christians of Lipetsk and Lipetsk Region charged because religious organisation had "carried out activity without displaying its official full name" in the form of a sign on its building, as established by police inspection

Appeal: none

45) 9 October 2018

Name: Konstantin Kostin

Punishment: none – case sent back

Court: Kansk District Magistrate's Court No. 147, Krasnoyarsk Region

Circumstances: unknown

Appeal: none

46) 16 October 2018

Name: Light of the Gospel Baptist Union Church

Punishment: 30,000 Roubles

Court: Kirov District Magistrate's Court No. 6, Ufa, Republic of Bashkortostan

Circumstances: church charged both for lacking a sign with its full official name and distributing literature not labelled with its full official name; pastor accepted guilt, but pointed out that the books were for internal use only and were never distributed, and that the incomplete sign in place at the time of the prosecutor's office inspection was only temporary

Appeal: none

47) 28 November 2018

Name: Makhalla Muslim community, Mostovaya

Punishment: unknown fine

Court: Lenin District Magistrate's Court No. 6, Ulyanovsk

Circumstances: unknown – failed to display full official name

Court: Khabarovsk District Magistrate's Court No. 69, Khabarovsk Region

Circumstances: Hare Krishna adherent charged for handing out books and talking about beliefs in a public square; defendant refers to Constitutional Court ruling of 13 March 2018 re. "system-defining" characteristics of missionary activity and denied trying to involve other people in any religious association; defendant was in possession of written authorisation to carry out missionary activity on behalf of a religious group, but "this did not help", according to lawyer; two witnesses stated that defendant had approached them to talk about his faith and offer them books for 100 Roubles – judge concludes that this is evidence of trying to involve people as members of a religious association
